## Highlights from the November 16, 2015 SFCCA Meeting

Marie Girardot, President of the South Four Corners Civic Association, opened the meeting by welcoming those in attendance. She then introduced our speaker, Officer Joy Patil (pronounced pahteel), from the Montgomery County Police Department.

Officer Patil began by encouraging us to follow the Homeland Security mantra: see something – say something. In other words, call in suspicious activity before a crime is committed. The three numbers to keep handy are:

911 for emergency | 301-279-8000 for reporting suspicious activity, non-emergent situations | 311 a community resource for reporting pot holes, graffiti, missing street name signs, code violations, etcetera.

Officer Patil then discussed trends. Theft from vehicles is the #1 crime in Montgomery County. "Tis the season to shop from cars!"

The guidelines she offered:

Don't leave items in your car.
Lock your car.
Leave it clean – nothing in sight.
Make the car look empty.

There is a dedicated patrol that investigates and watches trending areas where vehicle thefts are occurring. There are even decoy cars used to trap the criminals.

Citizens must report the crimes to the police in order for the detectives to be able to track the trends. Even reporting a crime two days after a crime occurs will help the crime investigators put pieces together.

Another trend at this time of year is package theft. Crooks are following the UPS trucks, the FEDEX trucks, and the USPS delivery trucks. Advice: have your packages delivered to your place of work, notify a neighbor you are expecting a package and have them retrieve it for you, ask the delivery company to place your package somewhere out of sight.

A third trend: an uptick in the volume of burglaries typically occurs between Christmas and January between the hours of 9:00 am and 3:00 pm.

Officer Patil's advice:

If you have a home alarm, use it!

Lock your doors and windows.

Have a home security assessment performed free of charge by your local police department station Keep a written record of make, model and serial number of your electronics. Keep this record in a safe place. It will help identify your goods in the case of theft.

Often times, when items are recovered, it is nearly impossible to identify the owner of the property because so many similar items are recovered. Items such as GPS units from cars, laptops, big screen TVs, etc. have serial numbers, yet the majority of people do not keep track of the serial numbers. Making it difficult to identify and return items to the rightful owner.

The typical response time, when calling 911, is 10 minutes. It of course dependent upon what is happening elsewhere in the county.

Officer Patil also told the group about the Citizens Academy. It is an extension of the Police Department's community policing efforts. Citizens are instructed on such topics as Criminal Law, Maryland Traffic Law and Major Crimes Investigation. The Academy is open to anyone 18 years of age or older who either lives or works in Montgomery County. The only cost to participants is their time. It runs 18 weeks, meeting once each week for 2-1/2 hours. There are two sessions offered per year, in the spring and in the fall. If you are interested contact:

Officer Patil also mentioned the RAD program offered by Montgomery County Park Police. RAD stands for: rape, aggression defense program. This program is a basic self-defense program for women and teens. For more information here is a link to the website: <a href="http://www.rad-systems.com/">http://www.rad-systems.com/</a> index.html

However, Officer Patil advised that the best defense: pay attention to your surroundings. \Drop the ear buds, put down the smartphone and the screens. For adults walking in neighborhoods: have your cell phone handy, use pepper spray, have a whistle if you are a jogger, be aware if you are out early morning or late evenings.

Larry Dickter mentioned that there is a high volume of cut through traffic, and drivers are "blowing through: stop signs." There was also mention that there is a \$575 fine for passing a school bus. Which brought up the question: if there are 4 lanes of traffic, how many lanes must stop for a school bus? The answer: if there is a median, dividing the directions of traffic, then all lanes of traffic traveling in the same direction as the bus are required to stop. If there is not a median, then all lanes of traffic, in both directions are required to stop.

Another issue that was discussed: suspicious individuals in the neighborhood. One in particular, is Giacomo. He has a swastika tattooed on his forehead. He has been banned from many areas. If you see him looking agitated, Officer Patil advised us to contact the non-emergency number and give them specific details.

Officer Patil's final word: Increase awareness. Look for suspicious behavior, such as people taking photos of houses, a person sitting in a car for long periods of time.

Another service of the county police department: a Mobile Crisis Team that will come out to evaluate a crisis situation. There are also Project Lifesaver bracelets recommended for the elderly, or autistic individuals.

These bracelets are used for tracking people on foot. It is a free program through the police department.

Thank you Officer Patil for taking the time to meet with us and to advise us on how to be savvier about crime prevention.

After the conclusion of Officer Patil's presentation, Larry Dickter provided an update on Transit issues.

Larry Dickter updated us on the status of two major transit projects of interest to our neighborhood: The 16-mile light rail line ("Purple Line") between Bethesda and New Carrollton and the proposed Montgomery County bus rapid transit system (BRT) currently under study.

After many years of delay and controversy, Larry said it appears that the Purple Line will move forward. Governor Hogan, who opposed building the Purple Line when he ran for office in 2014, recently reversed his position on the project subject to certain conditions, including an additional commitment of \$40 million in funding from Montgomery County. The original cost projection for the Purple Line of around \$1.7 billion is now estimated to be about \$2.46 billion, with \$900 million of that amount to be provided by the federal government -- if Congress agrees to appropriate the funds.

The state has received several bids from concessionaires who would complete design and construction, and help to finance, operate, and maintain the Purple Line for 35 years. The winning bid is supposed to be announced early in 2016, with construction scheduled to begin, if all goes according to schedule, in late 2016. Service is anticipated to begin in late 2021.

The Purple Line will operate mostly on surface roadways and will stop at 21 newly built stations, including nine in the Silver Spring area. It will connect with four Metro Rail stations along the way. The segment between the Lyttonsville and Bethesda stops will require bulldozing a 3-mile stretch of the popular Capital Crescent hiking and cycling trail. Hundreds of tall trees will be clear cut to make way for the train tracks, alongside which the trail is supposed to be rebuilt.

While the pros and cons of the Purple Line are still being debated, including ridership estimates regarded by some as grossly inflated, Larry said that ultimately it was the somewhat dubious "economic development" argument that proved to be decisive with the Governor. Among those most prominently leading the pro-Purple Line charge were developers and other land speculators, including the company planning to "redevelop" the Chevy Chase Lake area along Connecticut Avenue just south of the Beltway. County approval of this massive project was based in part on the assumption that a Purple Line station would be located nearby.

Larry also briefed us on the status of the bus rapid transit (BRT) study. The most recent news Larry announced is that, in the face of overwhelming public opposition and an apparent lack of political support, County Executive Ike Leggett has, for the moment at least, abandoned his intent to push for legislation by the state legislature and County Council that would establish an unelected, largely unaccountable Independent Transit Authority (ITA) with enormous powers of eminent domain (taking of private property) and taxation above and beyond the property

tax cap approved by County voters years ago. Mr. Leggett contends that the ITA, along with the significant tax hikes the agency could seek to impose on homeowners is the only way the County can pay for BRT (which would be ineligible for federal funding).

When the County Council voted two years ago to look at building and operating a BRT network along major County roads, including US 29 (Colesville Road), it also created what it called "Corridor Advisory Committees" (CACs) that would include residents who live along the corridors and who would provide a voice for impacted neighborhoods such as ours.

SFCCA's representative on the US 29 South CAC is former SFCCA President Karen Michels. In addition, Larry has been heavily involved in the BRT study through his role in the Greater Four Corners Alliance, a recently formed coalition of citizens and businesses who study local issues such as traffic and advocate on behalf of our area of the County.

According to Larry and many others involved including Karen, the CAC process, which began earlier in the year, is not going well. Millions of dollars are being paid to outside contractors and "facilitators" who have no knowledge of the affected communities (including ours) and who have withheld critical data and have tried to limit public engagement in the process as much as possible, thus undermining the intent of the County Council in setting up the CACs in the first place.

Larry said that thus far no credible data has been presented to justify spending billions of dollars that the County does not have to provide a service for which no need or demand has been established. Who would use the service, when they would use it, and for what purpose(s) are all questions that have gone unanswered.

One thing that **is** known is that BRT on US 29 south of White Oak would make traffic congestion approaching Four Corners even worse than it currently is. Also left unaddressed is the basic reality that, BRT or no BRT, most traffic along the corridor will continue to be motorists driving their own cars. (Larry also noted that among the most enthusiastic proponents of BRT along the US 29 corridor are the folks behind the mega-development being planned around White Oak, just north of Four Corners).

Moreover, Larry expressed the view that the singular focus on a service (BRT) in which Montgomery County goes it alone, does not take into account the regional nature of gridlock on our roads and the holistic approach that is needed to address the problem.

Unfortunately, more efficient, cost-effective, and immediate solutions (such as limited stop bus routes along existing bus lines) to ease traffic congestion are not being considered as alternatives to full service BRT through Four Corners, even though there is no room for dedicated bus lanes that a true BRT service would require, let alone any really feasible location where a station at Four Corners could be built.

The meeting concluded at 8:45 pm.


