#### **COUNTY COUNCIL APPROVES EXPRESS BUS SERVICE FOR US 29**

In response to a vigorous grass roots lobbying effort led by Four Corners civic leaders and other Silver Spring neighborhood activists who favor enhanced transit options in the eastern portion of the County, the Montgomery County Council finally agreed to fund limited stop, Ride-On Express service along the US 29 (Columbia Pike/Colesville Road) corridor beginning in early 2018. The new bus service will run from Burtonsville to the Silver Spring Transit Center every 15 minutes during the morning (5:30-9:00 am) and evening (3:00-7:00 pm) rush hours, at a cost to the County of less than one million dollars a year.

Ironically, the same special interest groups and individuals who have been leading the charge for a controversial "bus rapid transit" (BRT) network projected to begin operating along US 29 in 2020 at the earliest (and at an eventual cost of tens of millions of



dollars, if it is ever actually implemented) were "missing in action" during the campaign, opening the way for others to push for immediate transit improvements along the corridor.

Those activists who spearheaded the campaign for Express bus service had to overcome the resolute opposition of Council President Roger Berliner (who represents Bethesda, Chevy Chase, and Potomac), as well as the steadfast resistance from the Montgomery County Department of Transportation and its Director, Al Roshdieh.

The success of this campaign demonstrates once again that grass roots

mobilization, led entirely by volunteers without any financial backing, can and does effectively influence public policy and how our elected officials vote. Like other campaigns before it, this was a tightly focused, data-driven effort that managed to engage a support network of like-minded "ordinary citizens," including some from our own neighborhood, who sent emails and letters to Councilmembers, as well as placing phone calls to Council offices.

On any given issue, Councilmembers and their staff do track constituent communications. That is not to say they can be persuaded by public opinion in each and every case. But one thing is certain: If you do not convey your views to your elected representatives and key government officials, and do so in a clear and convincing manner, your views will not count.



# **Opening Doors**

#### MEET NEW NEIGHBORS, SHONELLE AND CHRISTA MAPP



1. How long have you been a resident of South Four Corners? We moved to South Four Corners from Brookland (DC) in January 2017. After exclusively searching for homes in DC, we stumbled across our neighborhood when

visiting a close friend. The tree-lined streets and well maintained brick homes were almost picturesque. We looked online and were pleasantly encouraged by the relative prices. And although we were eager to stay in the city, once we saw our current home the decision was instant.

- 2. What do you do? Christa has a background in land economy and facilities management, and works at the International Monetary Fund as a Senior Facilities Officer with contract management, data analysis and vendor management responsibilities. Shonelle has a background in industrial engineering and business management. She has held positions in both public and private sectors managing occupational, health, and safety compliance. She recently transitioned from her position as a Safety Engineer for the Senate to a self-employed Occupational Safety & Training Consultant.
- 3. What makes you special? As a couple, we are a walking billboard for diversity. Both of us are immigrants. Shonelle was born in Barbados and immigrated to MD over 30 year ago. Christa was born in Ghana and immigrated to VA just 4 years ago. Both of us have experience working in maledominated industries, environments with diverse or sensitive populations and teams in which we have been the "minority."
- **4.** What brings you joy? We love spending time together at home, entertaining friends, and exploring the many opportunities unique to living near the nation's capital. We are also huge foodies and enjoy Ethiopian, Indian, Thai, Brazilian and coastal cuisines.

In addition, we are avid travelers and have made it our priority to visit somewhere new at least once per year. Our most recent trips include Iceland, Costa Rica, and Panama. The thing we enjoy most about travel is immersing ourselves in the local sites, tastes, and sounds. There's so much beauty in this world, if one dares to push outside comfort and embrace the present.

**5.** What are the strengths and challenges of being who you are? As women of color, we have experiences in which our

abilities, expertise, and decisions are dismissed or devalued by others in the workplace. As lesbians in a largely heteronormative environment, we encounter insensitivity, disapproval, and ignorant comments. Sometimes these occurrences provide opportunities for dialogue. It is important to identify biases and address them with the individuals directly. We do not believe in letting hurtful language or behavior persist. Unfortunately it can be contagious. People tend to flock to the familiar and find comfort in commonality. Of all the challenges mentioned above, avoidance can sometimes be the most hurtful. We are both social, fun-loving and happy individuals, so that often means that we have to make the first step by approaching neighbors and new people. Usually once people get to know us as individuals, instead of labels, it's impossible to stay away.

- 6. In your opinion, what can we do to be a more inclusive **community?** There's no simple answer to that question. We did have one neighbor in particular who introduced himself right away. He had a sincere kindness to his character that was apparent from our very first meeting. Christa wasn't with me at the time when I introduced myself. I mentioned "my wife" during our exchange. He gently raised an eyebrow, seeming only mildly surprised by my mention of her, and continued to ask questions about the house and where we were from. In the days and weeks that followed, he offered us a few household items while we waited for our things to arrive. There are countless other ways that his small gestures have made us feel welcomed. Although we only talk a few minutes each week, our perception of this neighborhood has been shaped for the better by him. To answer the question, not so simply, an inclusive community begins with each neighbor. Let's all just treat each other a little less like strangers.
- 7. Share with us a quote that inspires you. What does it mean to you? "Your beliefs don't make you a better person. Your behavior does." This quote is pretty self-explanatory. We've seen lots of great diversity signage in and around the neighborhood. They definitely are a first step in letting the community know who you are and where you stand. Just don't forget, those beautiful words about inclusiveness also can be put to action by getting to know each other and engaging with each other individually.

The idea for an Opening Doors column was born during the first meeting of the Diversity & Inclusion Committee. In each newsletter, we will "open the door" to a new neighbor's life experience, helping each of us develop greater insight into the lives, challenges and aspirations of members of our diverse community.
