

BE AN INFORMED VOTER

hile some of you may already be anticipating this fall's general election for control of both houses of the U. S. Congress, an election of potentially great consequence, elections for all Maryland State and Montgomery County offices are also being held this year. Primary election day is June 26, with early voting taking place from June 14-21. The general election will be held on November 6.

Most Montgomery County voters know who the U. S. President is. Some may be able to name at least one of their two U. S. Senators. Fewer still may know who serves on their behalf in the U. S. House of Representatives. And it is a rare voter who can identify those who (one Senator, three Delegates) represent their district in the Maryland state legislature, let alone those who serve them on the County Council—even though they may have voted for most, if not all of them, and on multiple occasions.

Moreover, many citizens admit they vote for candidates solely because they have "seen his/her name before" or because the candidate showed up at an event the citizen attended, not because of any knowledge of the candidate's public policy positions or, in the case of an incumbent, the candidate's voting record.

Voters being unable to identify their elected officials is one thing; however, it is far more telling that many, if not most voters do not know where the candidates they just voted for stand on the issues. Is it any wonder then that 95% of incumbents are routinely reelected and that voters often experience "buyer's remorse" over their choices?

As a long-time local political activist who has been involved in numerous Montgomery County election campaigns, as well as having talked to hundreds (thousands?) of voters over the past quarter century, I can confirm all of the above.

We all know what is coming in the weeks ahead when our mailboxes will be filled to overflowing with literature from the candidates, almost all singing from the same hymnal. At this moment, I am looking at two recent "lit pieces" that just arrived in my mailbox. One candidate is telling me "She's running to get things done," while another is promising to "implement the best ideas to move Montgomery County forward". And it will be a rare candidate who doesn't promise to "grow the economy" —whatever that means. Fortunately for the candidates, few specifics are required.

In 2014, the last non-Presidential election year, just 16.2 percent of Montgomery County's 630,000 eligible voters cast ballots in that year's primary election, the lowest voter turnout of any Maryland county, and even worse than turnout four years earlier. Not to diminish his narrow, hard fought victory, it should be noted that our current District 5 representative on the Montgomery County Council was elected by roughly 8% of the voters eligible to cast ballots in that year's

Democratic primary (he was unopposed in the general election).

I believe there are a number of reasons for such an alarming decline in voter participation:

First, and perhaps foremost, is the collapse of trust in our nation's institutions and an accompanying erosion of confidence in government at all levels, with Montgomery County, where there is a widely felt disconnect between its citizens and their elected officials, being no exception.

When citizens no longer feel that representative government is operating in a transparent and responsive manner, and that special interests and large campaign donors (particularly developers) are driving the agenda at the expense of the public interest, they become disillusioned and cynical and, in one of the greatest threats to democracy itself, begin disengaging from "the process" altogether.

Just 18 months ago, in what has been widely interpreted as a vote of "no confidence" in the County's elected leadership, seven out of ten County voters ratified an amendment to the Montgomery County Charter limiting the number of terms that the County Executive and all nine County Councilmembers can serve. Shortly after one Councilmember dismissively called term limits a "stupid idea," nearly 300,000 "stupid" voters responded by approving term limits.

Secondly, voters stop voting when they are so disillusioned that they believe their vote "won't make a difference" or that it "doesn't count". (As for the latter, tell that to Al Gore who lost the Presidency in 2000 by 537 votes in Florida out of almost six million votes cast in that state; or, more recently, tell that to the two candidates for state

delegate in Virginia whose election literally ended in a tie vote, with the eventual winner's name being drawn from a ceramic bowl). Even more so this year in Montgomery County, with such an excessive number of candidates running for so many offices, it appears likely that more than a few races may be decided around the margins, some even by a handful of votes.

Most of the leading candidates for Mont-gomery County Council support zoning changes that could radically and irreparably transform Four Corners by allowing developers to build apartments within a 1/4 mile radius of Bus Rapid Transit stations

Another factor in the decline of voter participation and engagement may be the demise of local media outlets, and the relative inattention to Montgomery County by the D.C.-centric Washington Post. In such a media environment, it is extremely difficult for a challenger to get his or her message out to the public, even when he or she may offer a stark contrast to an incumbent. In what has been called a "media desert," highly opinionated and/or partisan bloggers, who are not bound to any journalistic norms, have moved in to fill the vacuum left by more traditional media.

Unfortunately, many voters lack a basic awareness of what the County Council does and why it is important who they elect to serve on it. I have talked to more than a few voters who say the issue they care most about is the County's unsustainable pace of growth and the failure to require developers to pay their fair share of the infrastructure needed to support their projects (roads, schools, police and fire protection, etc.),

costs that would otherwise be borne by County taxpayers. However, when I ask these same voters who they voted for to serve on the County Council (which makes all development-related decisions), they often say they voted for and intend to continue supporting candidates who hold views on growth and development that are diametrically opposed to their own views, something which they are totally unaware of.

Here in Four Corners, the residential character and diversity of our neighborhoods, which are currently zoned **single family residential (R-60)**, and our enviable quality of life are constantly under threat. However, once the newly elected County Council takes office in December, a new and unprecedented threat may be introduced sometime thereafter.

The reason is that **most, if not all,** of the leading candidates for Montgomery County Council, incumbents and challengers alike, have stated their support for zoning changes that could radically and irreparably transform Four Corners for the worse. This would be accomplished by allowing developers to build hundreds of apartment units (with severely limited parking) within a 1/4 mile radius of Bus Rapid Transit (BRT) stations, including those proposed for Four Corners and Burnt Mills. Once the area within that radius is rezoned for the hyper development that is envisioned, then almost anything goes—all in the name of "smart growth".

(One supporter of this scheme once advocated replacing our Safeway grocery store, whose location in Four Corners makes it that much easier for our neighbors to "age in place," with a Busboys and Poets lounge).

Think what that would mean for traffic congestion, school overcrowding, and parking for residents here in Four Corners. And once Four Corners and Burnt Mills just up the road become targets for "redevelopment," it may only be a matter of time before our cherished small businesses and community institutions like Carlo Santucci Deli,

The 4 Corners Pub, the Akhmedova Ballet Academy, the Arcade Barber Shop, Blue Heron Wellness, and others are forced out, just as "redevelopment" has killed untold numbers of small businesses in communities throughout Montgomery County.

Do you know which candidates favor such a radical transformation of Four Corners and its surrounding neighborhoods? Would it affect your vote one way or the other if you knew who they are?

With the Internet today, anyone can investigate almost any candidates' positions (though often stated in broad generalities and feel-good bromides) and/or voting record on the issues. Attend a candidates' forum, like the one Four Corners' civic associations (including SFCCA) held recently. Pick up a League of Women Voters Voter's Guide. If you subscribe to cable television, tune in to the County's cable channels to see if they are running interviews with the candidates this year.

Better yet, call or send emails to the candidates you want to question. Many of them have an "events" tab on their web site listing their campaign appearances, many of which take place before small groups and are open to the general public. You can go ask questions of the candidate, up close and personal, often times one-on-one.

At the same time so much of our attention is focused on national affairs and "breaking news" out of Washington, critical decisions are being made by our elected officials in Rockville. These decisions frequently and very directly affect our day-to-day lives, the livability of our neighborhoods and the desirability of Montgomery County as a place to call home. In this election year, it is up to you, the informed voters of Montgomery County, to learn all you can about the candidates before you vote—especially if you believe, as the late Speaker of the House Tip O'Neill was fond of saying, that "all politics are local". ■

PROTECT YOUR FAMILY AND PETS FROM TOXIC PEST-CONTROL CHEMICALS

nvironmental experts and government officials are concerned by the growing popularity of pesticides used by private pest control companies to try to control mosquitoes and ticks. They note that these treatments expose people and pets to toxic chemicals, and they are particularly

concerned due to health risks for kids, from asthma attacks to long-term learning and reproductive problems.

Two of the ingredients used by Mosquito Squad, one of many private pest control companies that has recently seen a boom in business, are bifenthrin and cyfluthrin. The U.S. Environmental Protection Agency labels bifenthrin as a possible

human carcinogen, and is currently reviewing both chemicals due to suspicions that they could cause allergic reactions and disrupt the endocrine system, says John Wargo, an environmental health professor at Yale University. The latter chemical is of particular concern to Wargo. Chemicals that mimic human hormones can scramble the body's natural signals, potentially leading to developmental disorders, sexual problems and obesity, among other health issues, he said. Recent research suggests harmful effects could even result from tiny doses. "This is especially worrisome for pregnant women and young children during rapid periods of

growth and development," said Wargo, highlighting the danger of the persistence and reapplication of the pesticides in people's yards. The undisclosed ingredients that are added to help Mosquito Squad's pesticides stick to foliage could also be harmful to people's nervous and

respiratory systems, Wargo said. (There are good reasons that the people spraying the chemicals wear hazardous materials suits.)

Critics also question whether pesticide sprays actually succeed in killing their intended targets, and whether they protect people from contracting bug-borne diseases. Biologists at Cornell University point out that targeting mosquitoes with

sprays only results in "temporary control" and "should only be considered as a last resort."

For non-toxic alternatives that are much less expensive, the Montgomery County Department of Environmental Protection provides a "Checklist to Reduce Mosquito Breeding":


